The course aims to increase skills in the critical decoding of the city and the ability to design in more complex urban contexts, responding to emerging issues in contemporary society

Course Goals & Objectives (list):

- stimulate the development of the understanding of complex urban organisms in their relationship with the wider territory and the use of plans as instruments of territorial transformation, at various levels;
- develop methods of characterization for a large urban area, based on a selection of analysis and information themes from different sources;
- design a strategy for the evolution of the territory, integrating economic and social aspects as well as a set of actions that impact on the physical component of the area under study, with a view to achieving the previously defined objectives and program;
- recognize an urban site□s critical situations and identifying relevant points to frame a structuring and qualifying transformation;
- establish the general principles of a multifunctional and articulating urban project of the site, in particular at the level of its spatial structure and functional logic and of critical response to the strategic;
- design an urban project capable to articulate different urban fabrics fragments, with varying morphological features, contributing to the public space transformation and operating on the particular theme of the semester using different levels of details
